#### APPROVAL OF AGENDA

Based on Superintendent Sena-Holton's recommendation, Member Tanuz motioned to approve the agenda, seconded by Vice President Garcia. Motion carried unanimously, 5-0.

#### STUDENT USE OF CELL PHONE COMMUNICATION DEVICES REVIEW

The board reviewed the proposed Cell Phone Communication Devices policy. The board discussed that the policy was not a complete ban on cell phone use. They liked that the policy listed approved times and locations of approved use of cell phone use. The board recommended revisions to the policy by adding locker rooms and restrooms as a specific restricted use area. In addition, the board recommended that once cell phones were confiscated during disciplinary actions, that the school would not keep possession of student's cell phone. Parents or guardians would have to pick up the cell phone.

#### EAST PECOS PROPERTY UPDATE

Superintendent Sena Holton gave the board an update of the East Pecos remediation project which will begin on November 11. She informed the Board that Board President Barrens and herself attended an abatement meeting with the Projector Director, the environment department, and the contractor working on the East Pecos Project. Superintendent Sena Holton overviewed the timeline of completion, the type of remediation planned for the portable and the main building, and how the contractor and maintenance will work together. Estimated completion will be the week of November 18, 2024.

#### PISD MEETING DISCLOSURE STATEMENT REVIEW

Superintendent Sena Holton shared with the board a disclosure statement Principal Morales created to combat nonproductive conversations among stakeholders that become negative. After reviewing the statement, the board decided to reduce the statement to shorter statement which will be used foster positive and productive dialogues with all stakeholders. Recommendation from the board is to place the statement on our website, school sites, newsletter. Board Vice President Garcia recommended Superintendent research Kindness 101.

#### STAFFING UPDATE

Superintendent Sena Holton reviewed the district's current vacancies. Discussion ensued for the need more substitute teachers and cooks.
